- (I) have passed at least +3 examination or such other qualification as are equivalent of +3 examination from a recognized university.
- (II) be a citizen of India.
- (III) have passed at least Diploma in Computer Application from a recognized Institute.
- (IV) be over 18(Eighteen) years and below 32 (Thirty-Two) years of age on the last date fixed for receipt of applications by the District Recruitment Committee i.e. 08.08.2025. Provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in accordance with the provision of the relevant Act, Rules, orders or instructions for the time being in force, for the respective reserved categories.
- (V) be able to speak, read and write Odia and must have passed a test in Odia equivalent to the M.E. Standard.
- (VI) be of good character.
- (VII) be of sound health, good physique and free from organic defects or bodily infirmity.
- (VIII) not have more than one spouse living, if married.

### A CANDIDATE IN ORDER TO BE ELIGIBLE FOR THE POST OF SALARIED AMIN SHALL:-

- (I) have passed the matriculation examination or equivalent examination of a recognized Board.
- (II) have passed Revenue Inspector Training.
- (III) be over 18(Eighteen) years and below 32(Thirty-Two) years of age on the last date fixed for receipt of applications by the District Recruitment Committee i.e. 08.08.2025. Provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in accordance with the provision of the relevant Act,

Rules, Orders or instructions for the time being in force, for the respective reserved categories.

- (IV) be able to speak, read and write Odia and must have passed a test in Odia equivalent to the M.E. standard.
- (V) be of good character.
- (VI) be of sound health, good physique and free form organic defects or bodily infirmity.
- (VII) not have more the one spouse living. If married.
- (VIII) have basic knowledge in computer application.

Knowledge of Current events and such other matters of everyday observation and experience as may be expected from an educated person.

#### 4. COMPUTER SCIENCE TEST FOR PRACTICAL

To test the proficiency of the candidates relating to matters like Text formatting of the paragraph, insertion of table, skill to print and save, file transfer, website searching/ browsing and downloading e-mail, use of pen-drive and other software etc. and programmes of accounting.

#### 5. VIVA-VOCE TEST:

To test and assess suitability of a candidate for the post with particular reference to the candidate's alertness, general outlook and potential qualities.

Envelope containing the application from. All copies of testimonials shall be signed by the candidates.

- 3. The application, if found defective/ incomplete in any respect or non-compliance of any of the requirements mentioned in the advertisement shall be summarily rejected.
- 4.
