ENGAGEMENT OF 01 (ONE) PART-TIME HOMEOPATHY AND 01 PART-TIME AYURVEDIC CONSULTANT UNDER THE AEGIS OF STAFF BENEFIT FUND OF CENTRAL RAILWAY.

A walk in interview will be held from open market for engagement of Registered Homeopathy & Ayurvedic Consultants part-time at Central Railway Hospital, Bhusawal on payment of consolidated honorium of Rs.37,500/- (Thirty Seven Thousand Five Hundred) per month without allowances in terms of extant instructions are as under -

- i) Period of Contract: The engagement will be offered purely on contract basis up to 30.06.2026 or availability of regular selected/nominated candidates whichever is earlier and subject to any instruction issued from time to time.
- 2) Vacancies:- Total 02 consultants will be filled from open market

## 3) Qualification required -

- A. Ayurvedic Consultants: The candidate must have a Diploma/Degree of not less than four years duration plus five years' experience after acquiring the four year Diploma/Degree course in the respective system of Medicine.
- B. **Homeopathy Consultants:** The candidate must have a Diploma/Degree of not less than four years duration and must have completed internship. Diploma holders should have at least 1½ years working experience.
- 4) The terms and condition of appointment of Homeopathy/Ayurvedic Consultants will be as under.
  - i) Homeopath/Ayurvedic Consultants will be given working facilities in one of the rooms for which necessary equipment/furniture and material will be supplied by the Railway.
  - ii) He/She will be responsible for proper maintenance of equipments, furniture and material given in his/her custody.
  - iii) Homeopathy/Ayurvedic Consultants will maintain a record of patients treated and submit the same to concerned officer every month.
  - iv) Homeopathy/Ayurvedic Consultants will submit a monthly statement of expenditure towards the medicines used and will submit indents of requirements well in advance to the concerned officer.
  - v) Homeopathy/Ayurvedic Consultants will attend the dispensary for 4 hours daily on all working days of the week. Timings will be decided in consultation with local SBF Committee and CMS, except the days on which the office remain closed.
  - vi) Homeopathy/Ayurvedic Consultants will issue no certificate for any purpose what so ever
  - wnat so ever.vii) Homeopathy/Ayurvedic Consultants will be paid honorium as decided by Railway Board subject to revision from time to time.
  - viii) Homeopathy/Ayurvedic Consultants will only attend patients at Homeopathic/Ayurvedic Dispensary.



- ix) Services of Homeopathy/Ayurvedic Consultants will be liable to be terminated on one month notice on either side or on completion of contract period without notice.
- x) No Railway Residential Accommodation will be provided to Homeopathy/Ayurvedic Consultants.
- xi) No Passes/PTO's or other fringe benefits as available to other Railway Employees will be allowed to them.
- xii) The age limit for the aforesaid Consultants has been fixed at 65 years and the existing consultant will seized to be engaged after 65 years.
- xiii) Homeopathy/Ayurvedic Consultants will dispense the medicines without the help of an additional hand.
- 5) Honorium:
  - i) Ayurvedic Consultants:- Rs.37,500/- per month
  - ii) Homeopathic Consultants:- Rs.37,500/- per month
- 6) Age: Consultants should cease to be engaged after 65 years. The Consultants Should not complete 65 years of age as on 30.06.2025.
- 7) Consultants while applying should indicate past service rendered if any.
- 8) Those fulfilling the above conditions may WALK-IN for an interview along with application in the format and all original certificate/testimonials duly enclosing attested copies of certificates/testimonials between 10:00 hrs to 13:00 hrs on the date and place mentioned below.
