Essential Qualifications:-

1. A master degree with 55% marks or an equivalent grade in a point scale, wherever the grading is followed, in Concerned/Relevant/Allied Subjects. Relaxation of 5% marks for SC/ST. OBC/Women (Non-creamy layer)/ EWS will also be given the benefit of such relaxation.
2. Physically Challenged persons from any part of the country will be given a relaxation of 5% marks at Master's Degree level. But both benefits shall not be admissible to the same candidate.
3. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September 1991.
4. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the

UGC, like SLET/ SET or who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and the relevant amendments made from time to time, as the case may be, shall be exempted from NET/SLET/SET.

5. Provided further that the candidates registered for the Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution/Organization awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/ Colleges/ Institutions subject to the fulfilment of the following conditions: -

- a) The Ph.D. Degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. Viva-Voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in referred journal (UGC Care/SCOPUS/Peer reviewed Journal).
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.
- f) The fulfilment of these conditions is to be certified by the Registrar/Dean (Academic Affairs/Faculty) of the University concerned.

Note:-NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

The Ph.D. Degree has been obtained from a Foreign University/Institution with a ranking among top 500 in the World University Ranking (at any one of the following):

(i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai JiaoTong University (Shanghai) or (iv) US News World Ranking.

Terms & Conditions:-

1. The number of vacancy/requirement in different subjects is provisional and subject to change, for which no reason shall be assigned.
2. The number of vacant posts may be changed at the time of appointment.
3. The engagement shall be made for a period of eleven months or till the regular appointment of the teachers is made, whichever is earlier.
4. The Reservation Policy of the Mahavihara will be strictly followed; category-wise and subject-wise as per the roster prepared by the institution. In order to get the benefit of reservation, claim must be made in the appropriate column of the application form, failing which the benefit of reservation will not be provided. If a candidate under reserved category qualifies in the general merit list he/she shall be appointed under the general category.
5. Age, experience and all other prescribed qualifications will be counted as on 18.08.2025. The minimum age requirement is of 23 years and maximum of 59 years.

6. The superannuated (Retired) teachers may also be considered for engagement as Guest Faculty subject to maximum age limit of 69 years.
7. All certificates and degree regarding educational qualifications must have been issued before the closing date for filling the application; failing which the candidature shall stand rejected.
8. The conversion of grade points into percentage will be made according to the conversion formula adopted by the concerned university. The proof of conversion of formula of the concerned university must be submitted by the candidate. The photo copy of front and reverse side of the result sheet indicating grade points should be submitted.
9. The experience of only such candidates will be valid, who were appointed or whose services were confirmed by University Selection Committee/College Service Commission/ College Selection Committee and duly signed by Registrar of the concerned university.
10. Degree under Distance Mode/Open University from institutions recognized by the UGC will be valid, subject to the circular(s) issued by DEB/ UGC from time to time.
11. The engagement of Guest Faculty in no circumstances be linked to regular appointments and would not be regularized at any stage.
12. The candidate should not hold any other teaching assignment.
13. The honorarium will be consolidated in nature at the rate of Rs. 1500/- per class with a maximum of Rs. 50000/- per months.
14. The engagement can be terminated by the competent authority at any time, without assigning any reason thereof.
15. The selected persons shall not be entitled to any other benefit like Provident Fund, Pension, Gratuity, Medical treatment, Seniority, Promotion etc. or any other benefits available to the teachers appointed on regular basis in the Mahavihara.
16. The selected Guest Faculty shall not be entitled to avail any allowance/facilities being extended to the regular/permanent faculty members of the Mahavihara.
17. The candidates should not have been convicted by any Court of Law. They would be required to furnish an affidavit to this effect.
18. All candidates shall have to come on the specified date, fixed by the Mahavihara for Document Verification; failing which they will not be considered for further process of recruitment.
19. In case any information furnished/provided by the candidates is found to be false or if the candidate has wilfully suppressed any information relevant to this engagement, he/she will be liable to be removed from the engagement and proper action, in accordance with the law shall be taken by the Mahavihara's authority.
20. Application incomplete in any aspect will be summarily rejected.
21. The candidature of the candidate will be rejected if the originals of all required certificates are not presented for verification at the time of interview and the decision of the University will be final.
22. The Mahavihara's Authority reserves the right of any amendment cancellation and changes to this advertisement as a whole or in part thereto without assigning any reason or giving notes.
