By selection (direct recruitment) through West Bengal Health Recruitment Board;

(b) Qualifications:

Passed H.S. (10+2) Examination or its equivalent with Physics, Chemistry, Biology and a two year Diploma course in Medical Technology in the concerned subject recognised by the State Medical Faculty of West Bengal under West Bengal Para Medical Council or conducted by any recognized Institution affiliated to any recognized University; OR, a Bachelor Degree in Medical Technology of the subject concerned from any Institution/ University recognized by Government of West Bengal.

E- Age:

Not less than 21 years and not more than 39 years as on the 1st January of the year in which advertisement is published.

Provided that the provisions of the West Bengal Services (Raising of Age limit) Rules, 1981 shall apply as long as the same remain in force.

Provided further that age may be relaxed for the candidates belonging to the categories of Scheduled Castes, Scheduled Tribes and Other Backward Classes as per Government rules or orders issued from time to time.

1) Passed H.S. (10+2) Examination or its equivalent with Physics, Chemistry, Biology:

A. Candidates are requested to upload Mark Sheet(s) including supplementary mark sheets, if any along with passed certificate of H.S. (10+2) Examination or its equivalent with Physics, Chemistry and Biology in the space provided for the same.

B. Candidates are requested to generate a single PDF containing Mark Sheet(s) including supplementary mark sheets, if any along with passed certificate of H.S. K- Instruction to the candidate:

- **DEPARTMENTAL CANDIDATES ARE ELIGIBLE FOR THE POST.** However, those who are in regular service in the same post, should not apply.
- **The Board may decide to hold Written Examination or Computer Based Test (CBT), at any subsequent stages of the recruitment process, for short listing of candidates for interview, and/or for preparation of Overall Performance List. Accordingly, the marks distribution pattern, mentioned in clause 'H' of this advertisement, may be changed partially or completely, if such Written Examination or Computer Based Test (CBT) is conducted for recruitment to the above mentioned post.**
- Mere empanelment shall not confer any right to be recommended and/ or appointed.
- Candidates must fulfil the essential qualification at the time of submission of application. No degree or experience certificate issued after the last date of submission of application will be considered.
- In the event, the last date of submission of online application is extended for whatsoever may be the reason, no particulars and certificates and/ or qualification (either essential or desirable) accrued during such extended period, shall be accepted.
