Passed H.S. (10+2) Examination or its equivalent with Physics, Chemistry, Biology and a two year Diploma course in Medical Technology in the concerned subject recognised by the State Medical Faculty of West Bengal under West Bengal Para Medical Council or conducted by any recognized Institution affiliated to any recognized University; OR, a Bachelor Degree in Medical Technology of the subject concerned from any Institution/University recognized by Government of West Bengal; OR, one year Diploma course in the concerned subject in Medical Technology, where basic qualification for undergoing the said course is B.Sc. (Pure / Bio) offered by the West Bengal State Medical Faculty or by any recognized university.

E- Age:

Not less than 21 years and not more than 39 years as on the 1st January of the year in which advertisement is published.

Provided that the provisions of the West Bengal Services (Raising of Age limit) Rules, 1981 shall apply as long as the same remain in force.

Provided further that age may be relaxed for the candidates belonging to the categories of Scheduled Castes, Scheduled Tribes and Other Backward Classes as per Government rules or orders issued from time to time.

K-Instruction to the candidate:

- DEPARTMENTAL CANDIDATES ARE ELIGIBLE FOR THE POST. However, those who are in regular service in the same post, should not apply.
