#### Stipend

Monthly stipend will be paid as per the prescribed rates governed by Apprenticeship Act.

Reservation of Vacancies: Government guidelines on Reservations will be followed.

#### **ELIGIBILITY CONDITIONS:**

- A. Qualifications: Prescribed qualification as mentioned above with a minimum of 50% marks in qualifying exams.
- B. Minimum Physical Standards: As prescribed in the Apprenticeship Rule 1992, clause 4 and amendments thereof if any.
- C. Previous Training: Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship Act 1961 in any Government or Public Sector or Private industrial organisation are not eligible to apply.

#### How to Apply

Cándidates should register themselves for apprenticeship in Government of India Apprenticeship Portal www.apprenticeshipindia.gov.in Candidate should select "Establishment Search" under Establishment menu in the above site and select "Institute for Design of Electrical Measuring Instrument, Mumbai" for undergoing apprenticeship training with IDEMI. This is compulsory. If the candidate does not select "Institute for Design of Electrical Measuring Instrument, Mumbai" for undergoing apprenticeship training, their application cannot be processed further.

#### GENERAL INSTRUCTIONS TO CANDIDATES

- 1. Engagement of Ex-ITI Candidates for Trade Apprenticeship Training will be done through web portal www.apprenticeshipindia.gov.in only. Applications will not be accepted through any other mode. IDEMI reserves right to alter the allocation of quota for trades any time during the process of engagement.
- 2. Candidates have to register themselves at www.apprenticeshipindia.gov.in Candidates have to enter their NAME as in SSC Certificate.
- 3. It is mandatory to upload SSC Marks Certificate, ITI Marks certificate (all semester) and Photograph, signature of the candidate in the portal. Applications without these will be summarily rejected. However, the company shall not be responsible for any application being rejected or candidate not shortlisted due to improper attachments and incorrect data.
- 4. Candidates should enter a valid email id and contact mobile number in the web portal. Also ITI Certificate number, Aadhaar Card Number, Date of Birth, Category (CAST), Council and Trade details. However, the company shall not be responsible for any application being rejected or candidate not shortlisted due to incorrect data.
- 5. Candidates who have passed Apprenticeship under Centre of Excellence (COE) scheme need not apply.
- 6. Web portal is being operated by DGET, Government of India. For enquiries regarding the issues related with web portal, the candidates are requested to contact help line numbers mentioned in the web portal. Correspondence with respect to functionality of portal will not be entertained by IDEMI.
- 7. No TA/DA will be paid for attending document verification process. Candidates will have to make their own arrangement for stay, if required, during verification process.
- 8. The selected candidates should be in a position to join the establishment on the prescribed date of joining. If the candidate does not report latest by scheduled date, it is assumed that he/she is not interested in the apprenticeship and his/her candidature will be forfeited.
- 9. Canvassing in any form will be treated as disqualification.
  - 10. IDEMI reserves the right to cancel the advertisement and / or the selection process there under. Decision of IDEMI Management regarding the selection will be final.
