### Notification for Engagement of Apprentice under the Apprentices Act, 1961(as amended) at HURL Barauni

HINDUSTAN URVARAK & RASAYAN LIMITED (HURL) was incorporated on 15th June, 2016 as a joint venture company by Coal India Limited (CIL), NTPC Limited (NTPC) and Indian Oil Corporation Limited (IOCL) as the lead promoters with Fertilizer Corporation of India Limited (FCIL) and Hindustan Fertilizer Corporation Limited (HFCL) as other two partners. The prime objective of HURL is to establish and operate state of the art environment friendly and energy efficient Natural Gas based new Fertilizer Complexes (Ammonia-Urea) of 2200 MTPD Ammonia and 3850 MTPD Urea (1.27 MMTPA neem coated urea) at each of the three locations, and simultaneously market their products, thus spurring economic growth in the eastern India.

All the three Units located at Gorakhpur, Barauni and Sindri have been commissioned and are under operation. HURL is currently serving to 17 states in the country. The Barauni Fertilizer unit is located in the Begusarai district of Bihar. Railway Station (Barauni) is at a distance of 8 km from the plant site.

## 1. ELIGIBILITY:

- a) **Educational Qualifications:** The applicant should have successfully completed the 03 Year Diploma Engineering / Graduation on full time regular basis in respective disciplines from any institution recognized by AICTE.
- b) **Age limit:** 18-25 years.
- c) Candidates with more than one year of prior apprenticeship training or experience as of 01.12.2025 are not eligible to apply
- d) Candidate who have already completed their apprenticeship training or terminated their apprenticeship training mid-way or pursuing apprenticeship in any other organization or any other units of HURL are not eligible.
- e) Candidates with qualification acquired through Distance Learning Mode or Part Time Mode or Correspondence mode or any other mode except full time regular basis shall NOT be considered.
- f) Candidates possessing higher professional qualifications such as B. Tech/ B.E or equivalent, MBA or equivalent or MCA / CA/ ICWA, LLB or equivalent shall NOT be considered. Suppression of information regarding possession or pursuing higher qualification shall render a candidate ineligible for consideration at any stage of selection/termination or any time during period of apprenticeship training.

## 2. STIPEND:

- a) A monthly stipend of Rs. 9000/- shall be given to the Graduate Apprentice Trainees and Rs. 8000/- be given to the Diploma Apprentice Trainees during their one-year Apprenticeship at as per norms / rate of stipend payable to apprentices per month of Apprenticeship Act, 1961/1973, Apprentices Rules 1992/2019 as amended from time to time.
- b) The selection for the Apprenticeship Trainee will not create/confer and/or confirm any right Whatsoever for appointment in HURL.
- c) The selected candidates will not be provided with any accommodation (or any other facility). They will have to make their own arrangements for their stay during the training period.

- a) Shortlisting of candidates will be done based on the merit list formed on the basis of percentage of marks obtained in the essential qualification applicable to the respective trade. There will be NO written test or interview. In case of two or more applicants have secured same marks, the applicant older in age amongst them( as per DOB in Xth marksheet) shall be considered first. Candidates registered on NATS portal, and applying against the notification shall be considered for selection.
- b) The shortlisted candidates will be called for document verification and will have to complete Pre-engagement medical fitness tests by District Civil Surgeon or equivalent authority before engagement as Apprentices Trainee as per Apprentices Act 1961. No any reimbursement shall be provided by HURL towards medical test.
- c) After successful completion of Documents Verification and successful Contract Approval of Apprenticeship on the respective portal only then they will be appointed as Apprentice Trainee. Seven (7) days period will be given to the trainee for joining. The Apprentice is expected to join on the given date, failing which his/her candidature may stand cancelled.
- d) No TA/DA shall be paid for joining / verification of documents.
- e) Apprentices shall be eligible for Annual Leave as per the provisions of the Apprentices Act, 1961 and any amendments made thereto from time to time.
- f) In case if we do not get enough response from the advertisement to fulfil the quota, we may accept applications on first come first serve basis. Only those candidates fitting the eligibility criteria mentioned in the advertisement will be considered.
