TERMS & CONDITIONS

1. Eligibility and Qualifications:

1.1 It is the candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualifications and experience. 2. Contractual Nature of the Position:

- 2.1. Appointments are on a contract basis for an externally funded project, with no claim to regular posts at AIIMS Bhopal or Funding Agency. The duration is project-specific, and employment may be extended or terminated at the discretion of the Project Investigator.
- 2.2. The contract automatically expires at the end of the specified period unless mutually renewed. Either party can terminate the contract with 30 days' notice or salary in lieu thereof.

3. Remuneration and Leave:
