- Candidates who have already worked as a Senior Resident under 3 years Central Residency Scheme for 3 years are not eligible for applying for the post of Senior Resident.
- Senior Residents who are already working in any Govt. institution shall apply through proper channel.

Qualification/Eligibility for Senior Resident(Under Residency Scheme):

- Post Graduate Degree or Diploma in concerned specialty from recognized university, registered with Delhi Medical Council or Medical Council of India or State Medical Council are eligible for the post of Senior Resident under Residency Scheme.
- However, if Post Graduate or Diploma doctors are not available, MBBS doctors without PG degree with two years of experience out of which 1 year of experience in the concerned Speciality from government hospital /private hospital, (NOT A PRIVATE CLINIC) may be appointed for 01 Year, as Senior Resident on contract basis.
- In accordance with the latest guidelines of the national Medical Commission(NMC/MCI).In case of non-availability of Super-Speciality Senior Residents(MCh/DM) for Super-Speciality departments, the Senior Residents from the concerned parent Broad Specialities will be considered.

Note: If No suitable candidate are available against the advertised, then any other candidate if present may be considered for Senior Resident irrespective of category, for short term engagement.

Age: Not exceeding 45 years as on 30.01.2026 (Relaxation for SC/ST/OBC as per rule).

- OBC Certificate should be in the prescribed form as per the Govt. of India instructions which should certify that the candidate does not belong to any one of the creamy layers.
- Reservation for PWD candidates is as per rule.

Terms & Conditions :-

- Private practices of any kind will not be allowed for full time contractual engagements. If found guilty, suitable action as provided under the relevant rules shall be taken.
- The recruitment will be purely on contractual basis and selected candidates will have no claim for regularization of the service in the hospital.
- Canvassing in any form shall be disqualification.
- The candidate who is in service should submit "No Objection Certificate" from the employer at the time of Interview.
- The decision of the Selection Board will be final on all aspects of selection and no further correspondence will be entertained under any circumstances.
- The posts are contractual. and the contractual engagement may be terminated discontinued by either side giving one-month prior notice to this effect without assigning any reason.
- No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion will be admissible.
