#### Academic Session 2025-26

The schedule for admission to M.Tech, MCA and M.Pharm programme of Tripura University for the Academic Session 2025-26 is as under:

#### **Commencement of Admission**

1. After the declaration of results of the Common University Entrance Test CUET-PG-2025 by the National Testing Agency, the University announces the commencement of admission to Postgraduate Programs (PG)-2025 from 26<sup>th</sup> May, 2025.

The candidates who are successful in CUET-PG-2025 must login to Tripura University admission portal <a href="https://tripuraunivcuet.samarth.edu.in/pg/index.php">https://tripuraunivcuet.samarth.edu.in/pg/index.php</a> for applying to their preferred Programs, subject to fulfillment of the eligibility criteria.

In case any candidate wants to correct any information provided by them in the registration portal, they may do so before payment of the registration fee. Once Registration fee is paid no further correction can be made in the registration portal.

There will be a one-time Registration Fees of Rs. 200/ for UR/OBC applicants and Rs 100/ for SC/ST/EWS applicants.

All the selected candidates need to report to the respective department for physical verification of their original documents before admission.
