It is notified for information of the candidates, who have appeared in CUET (PG)-2025 conducted by National Testing Agency (NTA) and have opted for the Postgraduate Programmes offered by Central University of South Bihar, that the admission process for the following Postgraduate Programmes shall start from **21-05-2025**.

2. Candidates, desirous to take admission in any of the above mentioned programmes offered by Central University of South Bihar for **Academic Year 2025-26**, shall have to register themselves on CUSB Portal through the link <https://cusbcuet.samarth.edu.in/pg/> by paying the registration fee (non-refundable) amounting to Rs.500/- for Gen/OBC/EWS and Rs.200/- for SC/ST/PwD for each programme from **21-05-2025 to 02-06-2025**.

3. Programme-wise **cut-off marks** for **1<sup>st</sup> Round** of Admission will be announced on **11-06-2025** for all the seats (**Annexure-1**). Eligible candidates who have registered themselves and have secured minimum cut-off marks announced for 1<sup>st</sup> Round of admission for respective programmes shall be required to deposit the programme fee for admission as per prescribed fee structure (**Annexure-2**) through payment link <https://cusbcuet.samarth.edu.in/pg/> within the prescribed date in order to secure the seat.

4. However, paying the programme fee shall not guarantee the provisional admission in a programme. Provisional admission will be granted strictly in order of merit and subject to fulfilment of eligibility criteria.

5. Candidates should ensure before registration that they have appeared in the Question Paper Code specified for a particular programme of studies.

### **INSTRUCTIONS TO THE CANDIDATES**

- The **Programme-wise cut-off** shall be uploaded on University's website [www.cusb.ac.in](http://www.cusb.ac.in)
- Eligible candidates who have secured the minimum cut-off marks in CUET (PG)–2025 for the respective programmes shall be required to pay the **programme fee** (refundable, if not selected for admission) as per the prescribed fee structure (**Annexure-2**) through the payment link <http://cusbcuet.samarth.edu.in/pg/> within the specified dates in order to secure their seat; failing this, they shall not be considered for provisional admission.
- If a candidate applies for more than one programme, she/he will be required to pay Registration fee (non-refundable) amounting to Rs.500/- for Gen/OBC/EWS and Rs.200/- for SC/ST/PwD for each programme.
- While registering for admission, the candidates shall be required to upload the scanned copy of their document/certificates as mentioned at **Annexure-3**.
- Registration for admission shall not guarantee provisional admission in a programme. Provisional admission will be offered only on the basis of position in the merit list, fulfillment of eligibility criteria and verification of document made by the concerned Department.

6. Candidates who deposit the **programme fee** but fail to secure admission in any round on account of lower marks shall be placed on the **waitlist** in order of merit for consideration in subsequent rounds. **Vacancies arising from cancellation or withdrawal of admission shall be filled from the waitlist strictly in order of merit.**
7. In case a candidate remains unsuccessful in securing admission by the end of the admission process, the **programme fee** shall be refunded. The refund process will be initiated after **October, 2025**.
8. Any candidate who have been granted provisional admission in any round and if she/he wants to withdraw/cancel their admission, she/he will have **to cancel the same through the SAMARTH portal only. Cancellation of admission via email or phone will not be considered.** Once, a candidate cancels her/his candidature through the SAMARTH portal, her/his name shall be removed from the merit list and no further chance of re-registration will be given.
9. In case of any cancellation/ withdrawal of admission by the admitted students, the refund of only **Programme fee** paid by the candidate will be made as per **UGC Guidelines and CUSB Policy.**
10. The refund process will be initiated after **October, 2025** and the amount will be refunded to **the same bank account/ payment mode through which payment has been made.** However, registration fee amounting to Rs. 500/- for Gen/OBC/EWS and Rs.200/- for SC/ST/PwD is non-refundable.
11. Candidates who are unable to obtain the relevant documents or certificates—such as the final semester/year grade report, marks sheet, degree certificate, migration certificate, or College Leaving Certificate (CLC) etc.—from their School/College/University at the time of registration shall be required to upload an undertaking in the prescribed format (**Annexure-4**) in lieu of the respective document(s).
12. Such Candidates who have appeared in the final semester or final year examination of their qualifying degree and are awaiting results may apply for admission. However, they shall be required to produce the result or proof of having passed the qualifying degree at the time of document verification in the beginning of 1<sup>st</sup> semester.
13. Candidates who are granted provisional admission must have appeared in the final semester or final year examination of their qualifying degree prior to the commencement of classes for the 1<sup>st</sup> semester. If it is found that a candidate is yet to appear in final examination of the qualifying degree during their 1<sup>st</sup> semester at CUSB, their admission shall be cancelled. For the purpose of admission, **appearing candidates** shall mean to those who have already appeared in their final semester or final year examination and are only awaiting the declaration of results.

14. Candidates who have submitted undertaking(s) in lieu of required documents at the time of registration for admission must ensure that all such documents/certificates are submitted on or before **31.10.2025**, failing which their admission will be cancelled.
15. Candidates who are granted provisional admission shall be required to produce the fee receipt and all original documents for verification at the time of reporting for classes.
16. All admissions shall be provisional subject to the verification of academic qualification and supporting documents. If it is found that a candidate has submitted false information or forged credentials, their admission shall be cancelled forthwith. Under such circumstances, the programme fee paid by the candidate shall be forfeited, and the whole responsibility shall lie on him/her.
17. In certain Programmes of Study, a limited number of supernumerary admissions may be offered under the **Paid/Payment Seat** Scheme. Admissions under this category shall be made strictly on the basis of merit, from among the candidates remaining in the same merit list after the conclusion of admissions under the regular mode. Candidates who could not secure admission in the regular mode, due to limited seats and their position in the merit list, may apply under the Paid/Payment Seat Scheme. The scheme shall be governed by the provisions laid down in the *Ordinance and Regulation governing the Paid/Payment Seats under Higher Fee Category in the Programmes of Study offered by CUSB*. Detailed notices for admission under the Paid/Payment Seat Scheme, wherever applicable, shall be issued separately after the completion of the regular admission process.
18. The classes of the students admitted in postgraduate programmes (Academic Year 2025-2026) will be commenced in off-line/physical mode w.e.f. **14-07-2025**.
19. Hostel facility is available. The hostel allotment list shall be declared separately by the University.
